If You are A Real Estate Broker

If you are a real estate broker in California, you may refer to 2024 California Code Business and Professional Code—BPC Division 3-Professions and Vocations. Generally. Chapter 5.5 Legal Document Assistants and unlawful detainer assistants. Article 1-General Provisions 6400. We suggest you read the entire code.

Under 6400 (d) section 1 (it is stated that “self help service” the following):

1. Providing general published factual information that has been written or approved by an attorney, pertaining legal procedures, rights or obligations to a person who is representing themselves in a legal matter, to assist the person n representing themselves. **This service, in and of itself does not require registration as a legal document assistant.** However, I suggest you discuss this with your attorney to clarify the meaning of this paragraph and subdivision as well as rules regarding compensation when using your real estate license as there are some gray areas.

In addition to this, you may wish to call the California Association of Realtors legal hotline and ask if you can fill in any forms if they have been approved by an attorney.
